SCO (previously named CALDERA INTERNATIONAL) and CALDERA signed a Consent Agreement on August 11, 1998 concerning the trademark "CALDERA".

SCO is the owner of the US trademark registration "CALDERA" (word) filed on April 3, 1995 under No. 74655365 and registered on May 13, 1997 under No. 2061968.

According to the Consent Agreement, SCO assigns now without any restriction or reserve to CALDERA who accepts, the entire right, title and interest in the above trademark registration. The aforesaid right, title and interest include the right to take action in respect of infringements which may have occurred prior to the date of execution of this assignment deed.

This assignment is made for and in consideration of the lump sum of 500 euros paid by CALDERA to SCO receipt of which is hereby acknowledged.



CALDERA will support all the fees relating to the recordal of this assignment in USA.



