

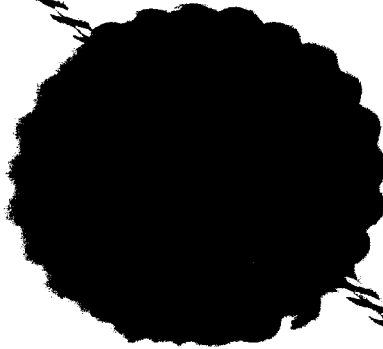




Notarial Certification
