NIKKO MATERIALS USA, INC.

1. The name of the corporation is Nikko Materials USA, Inc.
2. Article FIRST of the Restated Articles of Incorporation of the corporation is amended to read, in its entirety, as follows:

The name of the corporation is Gould Electronics Inc.

3. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
4. The amendment was adopted on the 15<sup>th</sup> day of February, 2006.
5. The amendment was approved by the shareholders. There is one voting group eligible to vote on the amendment. The designation of the voting group entitled to vote separately on the amendment, the number of votes in that voting group, the number of votes present at the meeting at which the amendment was adopted, and the votes cast for and against the amendment were as follows:

The voting group consisting of 5,000 outstanding shares of common stock is entitled to 5,000 votes. There were 5,000 votes present at the meeting. The voting group cast 5,000 votes for and no votes against approval of the amendment. The number of votes cast for approval of the amendment was sufficient for approval by the voting group.
