**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE (this "Termination and Release") dated as of June 15, 2010, from GE BUSINESS FINANCIAL SERVICES INC. (formerly known as Merrill Lynch Business Financial Services Inc.), in its capacity as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Lenders party to the Amended and Restated Credit Agreement, dated as of February 14, 2007 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement") to METALDYNE CHASSIS PRODUCTS, LLC, now known as DMI EDON LLC ("Grantor"), DIVERSIFIED MACHINE, INC. ("DMI"), DIVERSIFIED MACHINE BRISTOL, INC. ("Bristol"), DIVERSIFIED MACHINE MONTAGUE, INC. ("Montague") and DIVERSIFIED MACHINE, MILWAUKEE LLC ("Milwaukee" and together with Grantor, DMI, Bristol and Montague, collectively the "Borrowers").

WITNESSETH:

WHEREAS, pursuant to the Amended and Restated Security Agreement dated as of February 14, 2007 among Borrowers, UC HOLDINGS, INC., MEXICO PRODUCTS I, LLC and Administrative Agent (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement") and the Trademark Security Agreement dated as of December 8, 2009, in favor of the Administrative Agent (the "Trademark Security Agreement"), a security interest (the "Security Interest") was granted by Grantor to Administrative Agent in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the United States Patent and Trademark Office on December 9, 2009, at Reel 4110, Frame 0616; and

WHEREAS, Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Administrative Agent hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement and the Trademark Security Agreement.
2. Release of Security Interest. Administrative Agent hereby terminates, releases, and discharges its Security Interest in the Trademark Collateral, including the registered trademarks and trademark applications for registration listed in Schedule 1 attached hereto.

Any and all right, title, or interest of Administrative Agent in such Trademark Collateral and all proceeds thereof, including, without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral and any and all causes of action which may exist by reason of infringement of the Trademark Collateral, shall hereby cease and become void.
