NOW THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Assignor did and hereby does sell, assign, transfer and convey to Assignee, all of Assignor's right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark being assigned, all causes of action for any and all past infringements of the rights being assigned, and the right to collect and retain any proceeds therefrom in the United States.

Assignor hereby agrees that after the date hereof it shall execute and/or deliver, at Assignee's own cost and expense, such additional or other documents and instruments, and do such additional or other acts and things as may be required or reasonably requested by Assignee, its successors or assigns, to give effect to the provisions of this U.S. Trademark Assignment and to vest, perfect, confirm, record or otherwise reflect or give effect to Assignee's title in or title to the Trademark as set forth above.
