**RELEASE OF ASSIGNMENT OF SECURITY INTEREST
IN UNITED STATES PATENTS, TRADEMARKS AND COPYRIGHTS**

This RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN UNITED STATES PATENTS, TRADEMARKS AND COPYRIGHTS (this "Release"), is made effective as of May 6, 2010 by and from JPMORGAN CHAS BANK, N.A., a national banking association, whose address is 111 East Wisconsin Avenue, Milwaukee, Wisconsin 53202 (the "Bank"), in favor of Powervar, Inc. (the "Company").

WHEREAS, the Company and the Bank entered into (a) a Security Agreement (the "Security Agreement"), dated as of September 29, 2006 pursuant to which the Company granted the Bank a security interest in substantially all of its personal property and assets, and (b) a Confirmatory Assignment of Security Interest in United States Patents, Trademarks and Copyrights (the "Confirmatory Grant"), dated as of September 29, 2006 pursuant to which the Company confirmed its grant of a security interest in all of the patents (the "Patents"), trademarks and goodwill of the business in connection therewith (the "Trademarks"), and the copyrights (the "Copyrights" and together with the Patents and the Trademarks, the "Intellectual Property"), listed on Exhibit A attached hereto, in each case as security for the payment and performance of the Obligations (as defined in the Security Agreement); and

WHEREAS, the Bank has duly authorized the execution, delivery and performance of this Release;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Security Agreement.

SECTION 2. Release of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby assigns to and releases the Company from the security interest in and continuing lien on all of the Company's right, title and interest in, to and under the Intellectual Property, including without limitation, such Intellectual Property set forth on Exhibit A hereto.

SECTION 3. Release of the Security Agreement. This Release has been executed and delivered by the Bank for the purpose of releasing the security interest of the Bank in the Intellectual Property in the United States Patent and Trademark Office and the United States Copyright Office, as applicable.
