**TERMINATION OF SECURITY INTEREST IN TRADEMARKS
(CL FACILITY)**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 10, 2010, is made by Wachovia Bank, National Association, as Administrative Agent (the "Secured Party").

WHEREAS, The Newark Group, Inc. (the "Grantor") has granted security interests in certain personal property to the Secured Party, including without limitation security interests in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks") pursuant to the Loan and Security Agreement dated as of March 9, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "CL Credit Agreement");

NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases all mortgages, liens, and security interests granted to the Secured Party pursuant to the CL Credit Agreement in the following Trademarks:

1. the Trademarks identified on Schedule A attached hereto;
2. the goodwill of the business connected with the use of, and symbolized by, each Trademark identified on Schedule A; and
3. the products and proceeds of the Trademarks identified on Schedule A subject to the security interest granted pursuant to the CL Credit Agreement, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
