ASSIGNMENT OF TRADEMARK AND

Assignor further agrees, at the request of Assignee and without charge or cost to Assignee, to (i) execute and have executed any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Assignment; and (ii) fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this instrument of assignment with the United

States Patent and Trademark Office, so the Assignee's ownership of the Registration is duly made of record.
