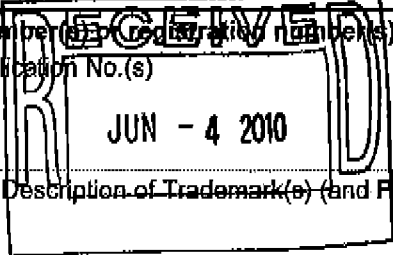

## ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (the "Agreement") dated as of June <sup>17</sup>~~12~~, 2009 ("Effective Date") is made and entered into by and between A. V. BRANDS, INC., a Delaware corporation ("Assignor") and ASCOWAY CO. LIMITED CORPORATION, a corporation organized in Hong Kong ("Ascoway").

WHEREAS, Assignor is the owner of the trademark for the mark Kutskova with a serial number of 76274766 registered with the United States Patent and Trademark Office on December 17, 2002 and was assigned to Assignor on November 6, 2007 (the "Mark").

WHEREAS, pursuant to an Asset Purchase Agreement dated May 29, 2009 between Assignor and Ascoway (the "APA"), ownership in the Mark was intended to be transferred from Assignor to Ascoway.

WHEREAS, Assignor desires to assign, and Ascoway desires to accept, all of Assignor's right, title and interest in and to the Mark, pursuant to the terms and conditions of this Agreement.

NOW, THEREFORE, pursuant to the terms and conditions of this Agreement and for other good and valuable consideration (including, but not limited to, the execution, delivery, and performance of the APA), the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby grant, assign, and convey unto Ascoway all of its right, title and interest in and to the Mark (including, but not limited to, common law rights, registrations and applications) together with the goodwill associated with such Mark, as well as all rights to damages and profits, due or accrued, arising out of past infringement of such Mark or injury to said goodwill and the rights to sue for and recover the same in Ascoway's own name.
2. In full consideration for the assignment set forth herein, Ascoway shall pay to Assignor One Dollar (\$1.00) upon the execution of this Agreement.
3. Assignor agrees to take such further actions and to execute such other documents, at Ascoway's request and expense, reasonably necessary to vest in and perfect for the benefit of Ascoway, the right, title and interest hereby granted, assigned and conveyed in this Agreement.
4. Upon execution of this Agreement, Assignor shall have no rights in or obligations with respect to the assigned Mark, and Ascoway shall bear the costs associated with the assigned Mark after the date hereof.

7. This Agreement constitutes the entire understanding among and between the parties with respect to its subject matter and cannot be modified, changed, or amended except in writing executed by the parties hereto, or their successors or assignees.

8. The Agreement shall be construed under the laws of the State of Maryland and each of the parties agrees to submit to personal jurisdiction in federal and/or state courts located in the State of Maryland.

9. The Agreement may be executed in counterparts, each of which shall be deemed to be an original for all purposes.

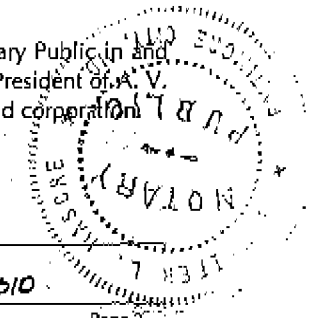
