Assignor hereby authorizes Assignee to file a trademark Application in all countries for any or all of said trademarks or service marks in Assignors' name, or in Assignee's name, or otherwise as Assignee may deem advisable, under any international or bilateral treaty, agreement or convention, or otherwise.

Further, Assignor agrees that, upon request and without further compensation, but at no expense to Assignor, it and its legal representative(s) and assigns will do all lawful acts, including having the appropriate persons execute papers and give testimony, that may be necessary or desirable for obtaining, sustaining, reissuing or enforcing a Trademark or Service Mark in the United States and throughout the world for said Trademark Portfolio, and for perfecting, recording or maintaining the title of Assignee, its successors and assigns, to said Trademark Portfolio, and any Trademarks or Service Marks granted for said Trademark Portfolio in the United States and throughout the world.

Assignor represents and warrants that it has not granted and will not grant to others any rights inconsistent with the rights granted herein.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any Trademarks or Service Marks granted, whether on said applications or on any subsequently filed extension or division to Assignee, its successors and assigns, as the assignee of the entire interest in said invention.


