## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Assignment"), dated as of December 30, 2009, is made by and between (i) UNI-MARTS, LLC, a Pennsylvania limited liability company ("Uni-Marts"), (ii) UNI-MARTS OHIO, LLC, a Pennsylvania limited liability company ("Uni-Ohio"), (iii) UNI REALTY OF LUZERNE, L.P., a Delaware limited partnership ("Uni-Luzerne"), (iv) UNI REALTY OF WILKES BARRE, L.P., a Delaware limited partnership ("Uni-Wilkes Barre"; Uni Wilkes Barre, together with Uni-Marts, Uni-Ohio and Uni-Luzerne, collectively the "Sellers" and each individually, a "Seller"), each of which is a Debtor and Debtor in Possession under Case No. 08-11037 (the "Case") under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court"), in favor of LEHIGH GAS CORPORATION, a Delaware corporation (hereinafter "Purchaser").

WHEREAS, Sellers and Kwik Pik LLC, a Delaware limited liability company ("Kwik Pik"), entered into that certain Asset Purchase Agreement, dated as of September 2, 2009 (as amended, the "Asset Purchase Agreement"); and

WHEREAS, pursuant to the Asset Purchase Agreement, Sellers have agreed to assign to Kwik Pik, and Kwik Pik has agreed to assume from Sellers, all of Sellers' right, title and interest in, to and under the Trademark Assets; and

WHEREAS, pursuant to that certain Assignment and Assumption of Asset Purchase Agreement dated as of even date herewith, Kwik Pik has assigned its right to acquire the Trademark Assets to Purchaser, and Sellers and Purchaser have consented to such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment by Sellers. Sellers, on behalf of Debtors, do hereby transfer, sell, assign and deliver to Purchaser, on the terms and subject to the conditions set forth in the Asset Purchase Agreement and the Sale Order, all of Sellers' right, title and interest in, to and under the Trademark Assets set forth on Exhibit A, attached hereto.

2. Acknowledge by Purchaser. Purchaser does hereby assume the Trademark Assets set forth on Exhibit A, attached hereto.

3. Definitions. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Asset Purchase Agreement.

4. Miscellaneous. This Assignment is being delivered pursuant to the Asset Purchase Agreement and shall be construed consistently therewith. In the event of any inconsistency between this Assignment and the Asset Purchase Agreement, the Asset Purchase Agreement shall control and prevail. Without limiting the foregoing, this Assignment shall be governed by, and construed in accordance with, the Laws of the State of Delaware, without regard to conflicts of laws principles, and, to the extent applicable, the Bankruptcy Code. This Assignment may be executed in counterparts, each of which shall be deemed an original and all of which, taken together, shall be considered one and the same Assignment.


