**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, effective as of June \_\_, 2010, is made by Bank of America, N.A., as Collateral Agent (as defined below), in favor of Harrah's License Company, LLC ("Company") as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Trademark Collateral Agreement, dated January 28, 2008 ("Security Agreement") by Harrah's Operating Company, Inc. (and each Subsidiary Party signatory thereto, including the Company), in favor of Bank of America, N.A., as collateral agent (the "Collateral Agent"), and recorded with The United States Patent and Trademark Office on February 4, 2008 at Reel/Frame No. 3719/0001, Company granted the Collateral Agent a security interest in and to all of its right, title and interest in various trademarks and applications and registrations therefor (the "Trademark Collateral") including Trademark Registration No. 1,702,280 for the mark "GARDEN OF THE DRAGON" and Trademark Registration No. 1,519,150 for the mark "SUPERBOOK" (collectively, the "Registrations");

WHEREAS, on December 24, 2003, the Las Vegas Hilton hotel/casino located at 3000 Paradise Road, Las Vegas, Nevada 89109 was acquired by Colony Resorts LVH Acquisitions, LLC ("Buyer") from LVH Corporation, as seller, and Park Place Entertainment Corporation as parent (collectively, "Sellers") and as part of that transaction (the "Acquisition") certain trademarks used at the Las Vegas Hilton property were assigned to Buyer and certain trademarks were made part of a perpetual license between the parties;

WHEREAS, the Registration for the "GARDEN OF THE DRAGON" mark was included in the Acquisition but for which no assignment for this mark was completed and therefore was included in the Trademark Collateral in error;


WHEREAS, the Registration for the "SUPERBOOK" mark was included in the perpetual license between the parties and in a desire to terminate the perpetual license and its obligations, the "SUPERBOOK" mark and its Registration was assigned to Buyer on April 20, 2010, and the perpetual license terminated;

WHEREAS, the Security Agreement shall continue to remain in full force and effect with respect to the remainder of the Trademark Collateral but excluding the Registrations;

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty and at Company's sole cost and expense, hereby RELEASES all of its right, title and interest in and to each of the Registrations and the goodwill associated with the Registrations.
