
DECLARATION

1. Affiant is the Chief Patent & IP Counsel for Cummins, Inc. and has personal knowledge of the following facts.
2. Cummins Engine IP, Inc. is a wholly owned subsidiary of Cummins, Inc.
3. The document previously recorded at Reel 2569 and Frame 0881 which purportedly assigned Registration Number 0860428 from Cummins Engine Company, Inc. to Cummins Engine IP, Inc. was submitted and recorded with erroneous information.
4. Registration Number 0860428 was never to be a part of that assignment. At the time of recordation of the document at Reel 2569 and Frame 0881, Cummins had no ownership interest in Registration Number 0860428.
5. The correct owner of Registration Number 0860428 is, and at all times relevant herein was, ProAir LLC, and Indiana Limited Liability Company, of 28731 County Road 6, Elkhart, IN 46514.
6. Therefore, the document recorded at Reel 2569 and Frame 0881 was recorded with erroneous information and should not impact ownership of Registration Number 0860428 in the name of ProAir LLC.
