TRADEMARK ASSIGNMENT

WHEREAS, Assignee is a wholly-owned subsidiary of Assignor.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

2. Assignor shall, upon the request and at the expense of Assignee, execute any further documents reasonably required by Assignee to secure and enforce the rights granted to Assignee under this Assignment.
