CONFIRMATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS:

A. ICL Industrial Containers ULC/ICL, Contenants Industriels ULC (the "Debtor"), an unlimited liability company existing under the laws of Nova Scotia with its chief executive office at 8607 Roberts Drive, Suite 250, Atlanta, Georgia, U.S.A. 30350, is the owner of the trade-marks/patents/industrial designs set forth in Exhibit "A" hereto, the registrations and applications for the trade-marks/patents/industrial designs identified therein and the underlying goodwill associated with such trade-marks/patents/industrial designs (collectively, the "Trade-Marks/ Patents/Industrial Designs"); and

B. Deutsche Bank Trust Company Americas, as collateral agent for certain persons (the "Collateral Agent"), with offices at 60 Wall Street, 2nd Floor, New York, New York, U.S.A. 10005, has entered into an agreement with the Debtor, as reflected by a separate document entitled the "Security Agreement" dated as of the 16th day of June, 2010 by which the Debtor granted to the Collateral Agent, for the benefit of the Secured Creditors, a security interest in, and pledges to the Collateral Agent for the benefit of the Secured Creditors certain property and undertaking of the Debtor now owned or hereafter acquired and certain property and undertaking in which the Debtor now or hereafter acquires any interest, including the Trade-Marks/Patents/Industrial Designs, in consideration of the provision of certain credit facilities to BWAY Holding Company and the Debtor;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged and in accordance with the terms and obligations set forth in the Security Agreement, the Debtor confirms the grant to the Collateral Agent of a security interest in and to the Trade-Marks/Patents/Industrial Designs.
