FIRST: Article ONE of the Corporation's Certificate of Incorporation is hereby amended to read in its entirety as set forth below:

Article One

The name of the corporation is Old HLL, Inc. (hereinafter the "Corporation").

SECOND: The foregoing amendment was duly adopted in accordance with Section 242 and Section 303 of the General Corporation Law of the State of Delaware.

THIRD: That the name change of Hayes Lemmerz International, Inc. to Old HLL, Inc. is one of the transactions contemplated by the Modified First Amended Joint Plan of Reorganization of Hayes Lemmerz International, Inc., and its Affiliated Debtors and Debtors in Possession, as Further Modified, dated as of April 9, 2003 (as such plan may be amended, supplemented or modified from time to time and confirmed on May 12, 2003, by the United States Bankruptcy Court for the District of Delaware, Case No. 01-11490 (the "Plan")) and, pursuant to Section 242 and Section 303 of the DGCL, is authorized and approved in all respects without any requirement of further action of the security holders (including the stockholders) or directors of the Corporation.
