RELEASE AND REASSIGNMENT
(Pabst Brewing Company - Trademarks)

THIS RELEASE AND REASSIGNMENT is made as of June 24, 2010, by BANK OF AMERICA, N.A., successor by merger to LaSalle Bank National Association, a national banking association ("Agent").

WITNESSETH:

WHEREAS, PABST BREWING COMPANY, a Delaware corporation ("Borrower") executed that certain Intellectual Property Security Agreement (the "IP Security Agreement") dated as of October 11, 2002, pursuant to which Borrower granted a security interest in and to the Trademarks and Licenses (as each are defined below);

WHEREAS, Borrower executed that certain Short Form Trademark Security Agreement (the "Trademark Security Agreement") dated as of January 29, 2007, pursuant to which Borrower granted a security interest in and to the Trademarks and Licenses (as each are defined below);

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on November 6, 2002 at Reel/Frame 2609/0570 ; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 29, 2007 at Reel/Frame 3470/0383; and

WHEREAS, the Borrower's obligations to Agent have been fully satisfied and, therefore, Borrower has requested that Agent release its security interest in the Trademarks and Licenses and reassign the same to Borrower.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Borrower's right, title and interest in and to all of its now owned or existing and filed and hereafter acquired or arising and filed:

(a) trademarks, trademark registrations, tradenames and trademark applications, including, without limitation, the trademarks and applications listed on **Schedule A**, attached hereto and made a part hereof, and (a) renewals and extensions thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout the world (all of the foregoing patents, patent registrations, tradenames and applications, together with the items described in clauses (a)-(d) of this subparagraph, are hereinafter referred to as the "Trademarks");

(b) license agreements with any other party, whether Borrower is a licensor or licensee thereunder, including, and the right to prepare for sale, sell and advertise for sale, all inventory and equipment now or hereafter owned by Borrower covered by such licenses (all of the foregoing property is hereinafter referred to as the "Licenses"); and

(c) the goodwill of Borrower's business connected with and symbolized by the Trademarks.

2. Agent hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Agent, all of Agent's rights, title and interest, in and to the Trademarks and Licenses.
