RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 22, 2010 ("Effective Date") by U.S. Bank National Association, (the "Collateral Agent") in favor of Holley Performance Products Inc., Holley Performance Systems, Inc., Weiland Automotive Industries, Inc., Nitrous Oxide Systems, Inc., Lunati Cams, Inc., Earl's Supply Company, Biggs Manufacturing, Inc., Hooker Industries, Inc., So-Cal Speed Shops, Inc., Efastparts.com, Inc., KHPP Holdings, Inc. and Holley Performance Products Holdings, Inc. (collectively, the "Pledgor").

WHEREAS pursuant to the terms and conditions of (i) that certain Trademark Security Agreement dated as of January 26, 2006 (the "2006 Trademark Security Agreement,") and (ii) that certain Trademark Security Agreement dated as of March 28, 2008 (the "2008 Trademark Security Agreement," and together with the 2006 Patent Security Agreement, the "Trademark Security Agreements"; each capitalized term used herein without definition shall have the meaning ascribed to such term in the Trademark Security Agreements), the Pledgor pledged and granted to Collateral Agent for the benefit of the Lenders a lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral, including, without limitation, (i) the trademark registrations listed on Schedule I attached hereto which security interest has been recorded on February 1, 2006 at Reel 3238 Frame 0532 at the U.S. Patent and Trademark Office, and (ii) the trademark registrations listed on Schedule II attached hereto which security interest has been recorded on March 31, 2008 at Reel 3749 Frame 0268;

WHEREAS, the Pledgor has paid all of its outstanding indebtedness to the Collateral Agent secured by Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreements, and hereby terminates, cancels, re-pledges, reassigns and released any and all collateral pledge, grant, assignment, lien on and security interests it has in the and to the Trademark Collateral, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Pledgor without any representation, warranties or recourse of any kind whatsoever.

The Collateral Agent shall take all further actions, and provide to the Pledgor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor, at Pledgor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
