OF CERTIFICATE OF INCORPORATION

Schmidt Engineering & Equipment, Inc. (the "Corporation"), organized and existing under and by virtue of the General Corporation Law of the State of Delaware, as amended (the "Act"), does hereby certify:

FIRST: That the Board of Directors (the "Board") of the Corporation, without the formality of convening a special meeting of the Board, by consent in writing pursuant to Section 141(f) of the Act, consented in writing that the following resolution to amend the Certificate of Incorporation of the Corporation, is advisable, and called a meeting of the stockholders of said Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of this Corporation be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:


"FIRST: The name of the corporation is Wausau Equipment Company, Inc."

SECOND: That thereafter, pursuant to resolution of its Board of Directors, the sole stockholder (the "Sole Stockholder") of the Corporation, without the formality of convening a special meeting of the Sole Stockholder, by consent in writing pursuant to Section 228(a) of the Act, consented in writing in favor of the amendment.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

FOURTH: That the capital of said corporation shall not be reduced under or by reason of said amendment.
