TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made in favor of EXTANG CORPORATION, a Michigan corporation ("Grantor"), by MFC CAPITAL FUNDING, INC., a Minnesota corporation, as agent (in such capacity, the "Agent") for the lenders from time to time party to the Credit Agreement referenced to below ("Lenders").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated November 16, 2007 and that certain Trademark Security Agreement, dated April 3, 2009 (collectively, the "Trademark Security Agreement") executed in favor of Agent, Grantor granted to Agent, for the benefit of itself and the Lenders, a security interest in all of Grantor's right, title and interest in and to each of its trademarks, trademark applications and registrations, service mark, service marks applications or registrations, all renewals thereof, trade names, including without limitation, the trademark applications and registrations set forth on Schedule 1 attached hereto, together with the goodwill associated therewith, all license agreements relating to any of the forgoing, and all income, royalties, damages and payments arising from any of the forgoing (collectively the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 14, 2007 at Reel/Frame 3678/0731 and on April 15, 2009 at Reel/Frame 3971/0015.

WHEREAS, Grantor has paid all of its outstanding indebtedness to Lenders.

WHEREAS, Agent wishes to release its security interest in the Trademarks and reassign to Grantor all of Agent's right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates on behalf of itself and the Lenders the Trademark Security Agreement and hereby terminates, cancels and releases any security interest it may have in the Trademarks and reassigns to Grantor any rights it may have in the Trademarks.

Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

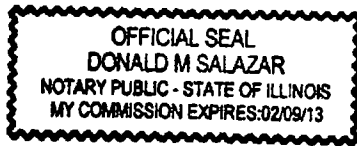
