WHEREAS, Assignor owns the trademark registrations identified on the attached Schedule A (hereafter referred to as the "Marks");


WHEREAS, Assignee is desirous of acquiring all of Assignor's right, title and interest in and to the Marks;

IN WITNESS WHEREOF, the parties hereto have caused their duly authorized representatives to execute this Agreement.


