## Assignment Nunc Pro Tunc

WHEREAS, American Transportation Exchange, Inc. ("Assignor"), a California corporation with its principal offices at 17512 Von Karman Avenue, Irvine, California 92614, adopted, used and owned the trademarks and corresponding registrations shown on the attached Schedule A (the "Trademarks");

WHEREAS, Montage Capital, LLC ("Secured Party"), a California limited liability company with its principal offices at 19925 Stevens Creek Boulevard, Suite 100, Cupertino, California, 95014-2358 entered into a loan agreement with Assignor on August 13, 2008 secured by the collateral property attached on Schedule A;

WHEREAS, on July 22, 2009, Assignor defaulted on its obligation pursuant to the loan agreement and as part of such transaction conveyed to the Secured Party the Trademarks, all rights thereto, and all business and goodwill associated with the Trademarks, after which carried on the business of Assignor as a going concern;

WHEREAS, on July 22, 2009, the Secured Party exercised its post default remedies with respect to the collateral property and conveyed the Trademarks, all rights thereto, and all business and goodwill associated with the Trademarks, to Logistikas, Inc. a California corporation (f.k.a. ATE Acquisition Corporation) ("Assignee/Transferee") after which Assignee/Transferee carried on the business of Assignor as a going concern;

WHEREAS, on April 28, 2010, the Assignee/Transferee changed its name from Logistikas, Inc. to Engage Transportation Management Systems, Inc. Assignee/Transferee is a California corporation with its principal offices at 19925 Stevens Creek Boulevard, Suite 100, Cupertino, California, 95014;

WHEREAS, the conveyance of the Trademarks to the Assignee/Transferee was not memorialized in writing; and

NOW THEREFORE, as Assignor conveyed the Trademarks to the Secured Party on July 22, 2009 and Assignee/Transferee is the successor to the Trademarks acquired by the Secured Party, this nunc pro tunc assignment is being executed now in order to clarify the ownership of the Trademarks, and to confirm that Assignor did assign unto the Secured Party all rights, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by the marks and the Secured

Party did assign unto the Transferee/Assignee all rights, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by the marks.


