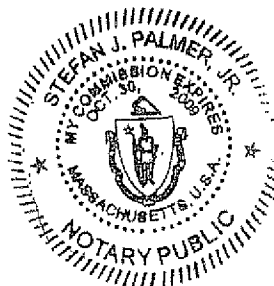

ASSET PURCHASE AGREEMENT

By and Among

INTEL CORPORATION,

RAY STATA, on behalf of the Stockholders as the Stockholder Representative

Dated July 31, 2009

"Material Adverse Effect" means, with respect to the Purchased Assets or the Business, any circumstance of, change in, or effect on, or group of such circumstances of, changes in or effects on, that results in or would reasonably be expected to result in, a material adverse effect on, or a material adverse change in, individually or when considered in the aggregate, the Purchased Assets or the Business.

"Offered Trademarks" means those trademarks listed on Schedule 3.12(b).

"Patent Assignments" means those certain patent assignments dated as of the Closing Date, to be executed by Seller in favor of Purchaser, each in substantially the form attached hereto as Exhibit C.

"Person" means an individual, corporation, partnership, association, limited liability company, trust, estate or other similar business entity or organization, including a Governmental Authority.

"Post-Closing Tax Period" means any Tax period (or portion thereof) ending after the Closing Date.

"Pre-Closing Tax Period" means any Tax period (or portion thereof) ending on or before the close of business on the Closing Date.

"Software and Other Technology" means the Intellectual Property, software and functional aspects of the commercial software known as Cilk++ for Windows and Cilk++ for Linux, as well as related tools and technology to facilitate the parallel programming of computers.

"Subsidiary" means, with respect to any Person, (a) any entity as to which more than fifty percent (50%) of the outstanding stock having ordinary voting rights or power (and excluding stock having voting rights only upon the occurrence of a contingency unless and until such contingency occurs and such rights may be exercised) is owned or controlled, directly or indirectly, by such Person and/or by one or more of such Person's direct or indirect Subsidiaries and (b) any partnership, joint venture or other similar relationship between such Person (or any Subsidiary thereof) and any other Person (whether pursuant to a written agreement or otherwise).

"Taxes" means (a) all foreign, federal, state, local and other net income, gross income, gross receipts, sales, use, ad valorem, value added, intangible, unitary, capital gain, transfer, franchise, profits, license, lease, service, service use, withholding, backup withholding, payroll, employment, estimated, excise, severance, stamp, occupation, premium, property, prohibited transactions, windfall or excess profits, customs, duties or other taxes, fees, assessments or charges of any kind whatsoever, together with any interest and any penalties, additions to tax or additional amounts with respect thereto, (b) any Liability for payment of amounts described in clause (a) whether as a result of transferee Liability, of being a member of an affiliated, consolidated, combined or unitary group for any period, or otherwise through operation of law and (c) any Liability for the payment of amounts described in clause (a) or (b) as a result of any tax sharing, tax indemnity or tax allocation agreement or any other express or implied agreement to indemnify any other person for Taxes; and the term "Tax" means any one of the foregoing Taxes.
