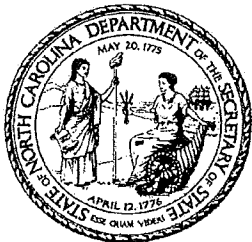

ARTICLES OF ORGANIZATION  
 INCLUDING ARTICLES OF CONVERSION

Pursuant to §§ 57C-2-21, 57C-9A-01 and 57C-9A-03 of the General Statutes of North Carolina, the undersigned converting business entity does hereby submit these Articles of Organization Including Articles of Conversion for the purpose of forming a limited liability company.

1. The name of the limited liability company is: Integrated Healthcare Solutions, LLC. The limited liability company is being formed pursuant to a conversion of another business entity.
2. The name of the converting business entity is: Integrated Healthcare Solutions, Inc. The organization and internal affairs of the converting business entity are governed by the laws of the State of North Carolina. A plan of conversion has been approved by the converting business entity as required by law.
