AGREEMENT OF RELEASE OF LIENS AND CHARGES

Kreos hereby irrevocably agree that the Liens on the IP Assets be canceled, discharged and removed from the USPTO records and/or from any other suitable records, and that the USPTO records and/or any other suitable records be updated to reflect the removal, cancellation, release and discharge of the Liens on the IP Assets
