All remaining provisions of the original Articles of Incorporation shall remain unchanged.

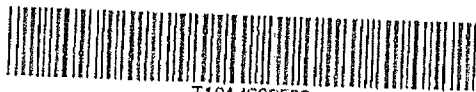

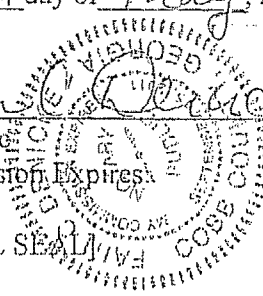
