## RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lenders hereby assign to and release Borrower from the security interest in and continuing lien on all of the Borrower's right, title and interest in, to and under the Trademarks, including without limitation, such Trademarks set forth on Exhibit A hereto.

SECTION 3. Release of the Security Agreement. This Release has been executed and delivered by the Lenders for the purpose of releasing the security interest of the Lenders in the Trademark in the United States Trademark and Trademark Office and worldwide.
