**AND ASSIGNOR HEREBY** represents and warrants that ASSIGNOR owns, and upon consummation of this assignment, ASSIGNEE shall own, the MARK free and clear of any third party right, security interest, mortgage, deed of trust, charge, pledge, proxy, adverse claim, lien, equity, power of attorney, or restriction of any kind, including, but not limited to, any restriction or servitude on the use, transfer, receipt of income, or other exercise of any attributes of ownership of the MARK.

**AND ASSIGNOR HEREBY** covenants and agrees that it will communicate to the ASSIGNEE, and its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting said MARK, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and if necessary aid the ASSIGNEE, and its successors, legal representatives and assigns, to obtain and enforce proper trademark protection for said MARK in all countries.
