TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release of Trademark Security Agreement (the "Termination and Release"), is made as of July 1, 2010, by JPMorgan Chase Bank, N.A., as Administrative Agent (in such capacity, together with its successors and assigns, the "Administrative Agent"), in favor of Palm, Inc., a Delaware corporation (the "Borrower"), and the Subsidiaries of the Borrower listed on Schedule I hereto.

RECITALS

A. Reference is made to that certain Guarantee and Collateral Agreement, dated as of October 24, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Borrower, the Subsidiaries of the Borrower party thereto and the Administrative Agent and that certain Credit Agreement, dated as of October 24, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the Lenders party thereto, the Administrative Agent and Morgan Stanley Senior Funding, Inc., as syndication agent.

B. In connection with the Security Agreement, the Borrower, Palm Trademark Holding Company, LLC ("Palm Trademark Holding") and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of October 24, 2007, and Palm and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of January 25, 2008, and Palm, Palm Trademark Holding and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of October 2, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, each a "Trademark Security Agreement"), whereby Borrower granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Borrower's right, title and interest in and to the Collateral (as defined below).

C. The Trademark Security Agreements were filed with the United States Trademark Office on November 13, 2007 at Reel 3660 and Frame 0215; on January 29, 2008 at Reel 3706 and Frame 0406; and on October 7, 2009 at Reel 4075 at Frame 0319 to evidence the security interest in Trademarks.

D. Borrower has satisfied all obligations under the Credit Agreement and the Security Agreement, including, without limitation, all Obligations, and as a result, Borrower has requested, and Administrative Agent has agreed, to release its security interest in the Collateral.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent agrees as follows:

1. Administrative Agent hereby expressly terminates and releases its security interest in and to the following assets and properties owned by Borrower and the Subsidiaries of Borrower listed on Schedule I hereto (the "Collateral"):

(a) all trademarks, service marks, trade names, domain names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including

registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule II (the "Trademarks");

(b) all goodwill associated with or symbolized by the Trademarks; and

(c) all assets, rights and interests that uniquely reflect or embody such goodwill.

2. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement.

3. Administrative Agent authorizes and requests that the United States Trademark Office and any other government office record this Termination and Release.
