TRADEMARK COLLATERAL SECURITY AGREEMENT

THIS TRADEMARK COLLATERAL SECURITY AGREEMENT (this "Agreement"), dated as of June ~~1~~² 2010, is made by Evident Technologies, Inc., a Delaware corporation, with its principal office at 45 Ferry Street, Troy, New York 12180 ("Borrower"), in favor of those individuals and entities listed on Schedule I hereto (each a "Secured Party" and together, the "Secured Parties").

WHEREAS, Borrower has adopted, used and is using, and is the sole owner of the marks set forth on Schedule II hereof (the "Marks");

WHEREAS, pursuant to that certain Priority Term Facility Credit and Security Agreement dated September 23, 2009, by and among Borrower and the Secured Parties, and any and all modifications, consolidation and extensions thereof (the "Security Agreement"), as collateral security for the prompt payment and performance in full when due (whether at stated maturity, by acceleration or otherwise) of the Obligations (as defined in the Security Agreement), Borrower pledged and granted to the Secured Parties, for their ratable benefit, a security interest in all of Borrower's right, title and interest in certain collateral, including the Marks, together with the goodwill of the business symbolized by the Marks;

WHEREAS, pursuant to that certain Final Order Approving Debtor-In-Possession Financing and Authorizing Use of Cash Collateral and Providing Adequate Protection Therefor of the United States Bankruptcy Court, Northern District of New York filed September 14, 2009 and entered September 15, 2009 (Case 09-12515-1-rel) (the "Order"), the Secured Parties were granted a superpriority first position continuing security interest in all of the assets of Borrower upon the terms and conditions set forth in

the Security Agreement (the "Security Interest") and all prior security interests in the Trademarks were extinguished, including the security interest recorded with the United States Patent and Trademark Office on January 9, 2008, at Rec/Frame: 3692/0676; and

WHEREAS, it is the purpose of this document to memorialize the Security Interest in a form suitable for recordation in the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of September 23, 2009, Borrower does hereby confirm the grant of and grant to the Secured Parties a lien and security interest in and to the Marks, all registrations and applications for registrations of the Marks, including the registrations and applications identified on Schedule II, together with the goodwill of the business symbolized by the Marks and together with all of Borrower's right to sue and recover for infringement of the Marks, free and clear of all liens, claims, charges, security interests, and other interests or encumbrances, which security interest shall secure the prompt payment and performance in full when due of the Obligations, as set forth in the Security Agreement.

Borrower hereby acknowledges and affirms that the security interest granted in this Agreement is granted in conjunction with the Security Interest granted to the Secured Parties under the Security Agreement and those rights and remedies of the Secured Parties which are now or subsequently available to the Secured Parties as a matter of law or equity.

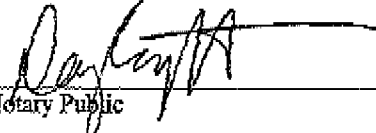
