**CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION OF
TEYDO HOLDING INC.**

Teydo Holding Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (hereinafter called the "Corporation"), does hereby certify that:

1. The Certificate of Incorporation of the Corporation is hereby amended by deleting Articles FIRST and FOURTH thereof and insert the following in lieu thereof:

FIRST: The name of the Corporation is FindWhere Holding, Inc. (hereinafter the "Corporation").

FOURTH: The total number of shares of stock which the Corporation shall have authority to issue is 50,000,000 shares of Common Stock, par value \$0.01 per share. Each outstanding one share of Common Stock of the Corporation issued and outstanding as of March 5, 2008 (but not any shares of common stock issued after March 5, 2008) is hereby split into 20 shares of Common Stock of the Corporation, and no change in the par value of the Common Stock shall result from the foregoing stock split.

2. The foregoing amendments were duly adopted in accordance with the provisions of Sections 242 and 228 (by the written consent of the stockholders of the Corporation) of the General Corporation Law of the State of Delaware.
