CONFIRMATION OF RELEASE OF SECURITY INTEREST

This Confirmation of Release of Security Interest is made as of July 2nd, 2010 by The Neat Company, Inc., a Delaware corporation and successor-in-interest to Digital Business Processes, Inc. (the "Company").

WHEREAS, pursuant to a general security agreement dated December 20, 2007 (the "General Security Agreement"), the Company granted to MMV Finance Inc. (successor to MMV Finance Canada, Inc., "MMV"), a security interest, lien and charge in all of the Company's right, title and interest in and to the intellectual property listed on Schedule A attached hereto, including, without limitation, the copyrights, trademarks, patents and trademark and patent applications and registrations listed therein, and in and to any and all continuations, continuations-in-part, updates, developments, divisions, reissues and reexaminations which issue therefrom;

WHEREAS, the Company has paid in full all Liabilities (as defined in the General Security Agreement) to MMV (the "Payment"), the Credit Agreement (as such term is defined in the General Security Agreement) and General Security Agreement are terminated and MMV has released its interest in the Collateral (as such term is defined in the General Security Agreement), including, without limitation, the intellectual property listed on Schedule A attached hereto; and

WHEREAS, in connection with the Payment, pursuant to a Payout and Authorization to Discharge dated June 22, 2010, MMV irrevocably appointed the Company and its counsel as its true and lawful attorney-in-fact to execute any discharge statements relating to MMV's release of its interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company, on behalf of MMV, hereby:

1. confirms the release to the Company any and all liens, security interests, right, title and interest of MMV pursuant to the General Security Agreement in the Company's Intellectual Property (as defined in the General Security Agreement) listed on Schedule A attached hereto, including, without limitation, the copyrights, trademarks, patents and trademark and patent applications and registrations listed therein, and in and to any and all continuations, continuations-in-part, updates, developments, divisions, reissues and reexaminations which issue therefrom; and


2. authorizes and requests that the United States Patent and Trademark Office and any other location where the security interest was filed note and record the existence of such release hereby given.
