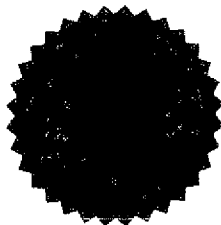

2005.


