## TRADEMARK ASSIGNMENT

This Agreement is made by and between IntelliServ International Holding, Ltd. WHEREFORE, for good and valuable consideration to it in hand paid, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby sells, assigns, transfers, and conveys to Assignee, its successors and assigns, Assignor's entire right, title, and interest in and to the Trademarks in the United States of America, its territories, and its possessions, together with the goodwill of the business in which the Trademarks are used, the goodwill associated with and/or symbolized by the Trademarks, that portion of Assignor's business to which the Trademarks pertain, and any and all rights and causes of action (including damages recoverable thereby) for past, present, and future unauthorized use of the Trademarks, including but not limited to all rights and causes of action for infringement and unfair competition.

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and enforce full the benefits of the rights and interests herein sold, assigned, transferred, and conveyed. This Agreement shall be binding on the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee.

Assignor represents and warrants that it owns all right, title, and interest in and to the Trademarks, that it has the authority to transfer all of the rights sold, assigned, transferred, and conveyed pursuant to this Agreement.

This Agreement is effective as of this 7th day of July, 2010. The undersigned hereby represent and warrant that they have the authority to execute this Agreement on behalf of their respect entities.

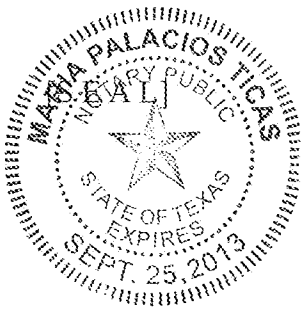
