Re: Notice of Disposition of ICQ LLC

Dear Sirs,

Reference is made to the credit agreement (the "Credit Agreement") dated as of December 9, 2009 entered into among AOL INC. ("AOL"), the lenders from time to time party thereto, and Bank of America, N.A., as Administrative Agent.

Capitalized terms used herein shall have the same meaning as in the Credit Agreement, unless otherwise defined.

On April 28, 2010, AOL entered into a securities purchase agreement in connection with the disposition of ICQ LLC (the "Company"), a Subsidiary Guarantor under the Loan Documents, for cash (the "Disposition"). The transaction is expected to close on or after July 1, 2010 (the "Disposition Date"). The effectiveness of the Disposition is subject to customary terms and conditions which are expected to be satisfied on or prior to the Disposition Date.

In connection with the Loan Documents, the Company certifies that:

- (i) no Default or Event of Default has occurred and is continuing;
- (ii) the Disposition is permitted under Section 7.05(k) of the Credit Agreement and is in compliance with the other Loan Documents;
- (iv) upon the effectiveness of the Disposition, and pursuant to Section 11.4(b) of the Security Agreement, the Collateral subject to the Disposition shall be automatically released from the Liens created thereunder; and
- (v) upon the effectiveness of the Disposition, and pursuant to Section 11.4(b) of the Security Agreement and Section 27 of the Guarantee, the Company shall cease to be a wholly-owned Domestic Subsidiary of AOL and shall be automatically released from its obligations thereunder.


In connection with the Disposition and Section 11.4(b) of the Security Agreement, we hereby request the Administrative Agent, at AOL's expense, on or prior to the Disposition Date, to deliver (i) such releases necessary to evidence the termination of the Liens created

under the Loan Documents on the Company and its assets, and particularly we hereby request the Administrative Agent to (x) terminate all UCC financing statement filed against the Company as a Subsidiary Guarantor under the Loan Documents evidencing the security interest of the Administrative Agent and the Lenders in the Company and its assets and (y) terminate all filings made in the United States Patent and Trademark Office evidencing the security interest of the Administrative Agent and the Lenders in the Intellectual Property Collateral of the Company and (ii) any Collateral in the Administrative Agent's possession that is subject to the Liens that are being released pursuant to clause (i).

**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of July 8, 2010, from Bank of America, N.A., a national association, as Collateral Agent (the "Agent") pursuant to the Credit Agreement dated as of December 9, 2009, to AOL, Inc. (the "Obligor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of December 9, 2009, (the "Security Agreement"), made by the Pledgors (as defined therein) in favor of the Agent, a lien and security interest (collectively, the "Security Interest") was granted by the Pledgors (including the Obligor) to the Agent, on behalf of the Secured Parties (as defined therein), in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 9, 2009, among the Agent and Obligor (the "Trademark Security Agreement"), Obligor, by reference to the Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office at Reel 4112 and Frame 0615; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Obligor's right, title and interest of every kind and nature as of the date hereof in, to and under (a) the Trademarks listed on Schedule A hereto, (b) all Goodwill (as defined in the Security Agreement) associated with such Trademarks, and (c) all Proceeds (as defined in the Security Agreement) of any and all of the foregoing.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in, to and under the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Termination of Intellectual Property License. The Agent hereby terminates any and all license rights in and to the Trademark Collateral granted to the Agent under § 6.1 of the Security Agreement.

4. Further Assurances. The Agent hereby agrees to duly execute, acknowledge,

procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
