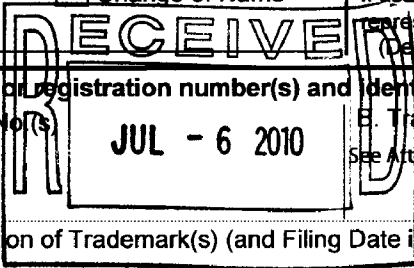

## RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **May 25, 2010** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Security Agreement, dated as of **March 13, 2009** and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Continental Disc Corporation**, (the "Debtor") and **Robert Family Holdings, Inc.** (the "Borrower") and the Secured Party;

### W I T N E S S E T H:

WHEREAS, pursuant to the Security Agreement which was recorded in the records of the United States Patent and Trademark Office, the Debtor and Borrower granted to the Secured Party a continuing security interest in all of the Debtor's United States Intellectual Property Collateral including those set forth;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the

Intellectual Property Collateral including those set forth, and discharges, quit claims and relinquishes unto **Continental Disc Corporation**, and **Robert Family Holdings, Inc.** (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interest granted to Secured Party in the Intellectual Property Collateral.
