NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by ASSIGNOR, ASSIGNOR has sold, assigned and transferred and does hereby sell, assign and transfer unto ASSIGNEE, and ASSIGNEE'S successors and assigns, effective as of the 30th day of September 2008, all right, title and interest, worldwide, in and to the Marks, together with the goodwill of the business symbolized by the Marks and the registrations and the referenced applications for registrations of the Marks and the right to recover damages for past infringement, if any.
