ASSIGNMENT OF TRADEMARKS

C. Assignor and Assignee now desire to amend the Assignment Agreement on the terms set forth in this Amendment. All capitalized terms used in this Amendment, unless otherwise defined herein, shall have the meanings given to them in the Assignment Agreement

AGREEMENTS:

NOW, THEREFORE, Purchaser and Seller hereby agree as follows:

1. Recitals. The foregoing recitals are incorporated herein by this reference. Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.



3. Counterparts. This Amendment may be executed in counterparts each of which shall be deemed a fully executed original.


