ARTICLES OF AMENDMENT

(1)

The stockholders of C & J Chemicals, Inc., a corporation organized and existing under the Laws of the State of Georgia, did on the 15th day of April, 1985, adopt an amendment to the Articles of Incorporation of said Charter, to-wit:

"The name of the corporation, C & J Chemicals, Inc., shall be changed to Enforcer Products, Inc."

Said amendment was adopted by the unanimous vote of the stockholders of the corporation, being John R. Doyle, the holder of two hundred fifty (250) shares of stock, Wayne Biasetti, the holder of two hundred fifty (250) shares of stock, and James D. Biggs, the holder of two hundred fifty (250) shares of stock, being the total common stock of the corporation, and John R. Doyle, Wayne Biasetti and James D. Biggs being the only persons entitled to vote thereon.

The applicant prays that the Charter issued to the corporation on the 14th day of February, 1979, by the Secretary of State be amended as follows:
