## ASSIGNMENT OF INTELLECTUAL PROPERTY

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, EBSCO does hereby sell, assign, convey, transfer and deliver to PI, for its own use and enjoyment and for the use and enjoyment of its successors and assigns, the entire worldwide rights, title and interest in and to the IP, together with the goodwill of the business symbolized thereby or otherwise associated with the business conducted in connection with the IP, and all income, royalties, damages and payments which may hereafter become due or payable in respect thereof, and to all causes of actions (either at law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement, dilution or other unauthorized use or impairment of the rights assigned to EBSCO under this Assignment of Intellectual Property.
