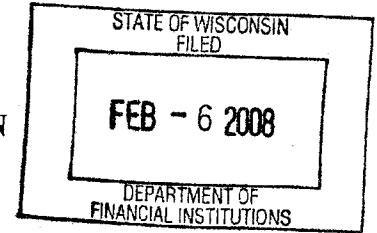

TO
RESTATED ARTICLES OF INCORPORATION
OF
OSHKOSH TRUCK CORPORATION




Pursuant to Section 180.1006 of the Wisconsin Business Corporation Law, the undersigned officer of Oshkosh Truck Corporation, a Wisconsin corporation incorporated under the Wisconsin Business Corporation Law (the "Corporation"), hereby certifies, in accordance with all applicable provisions of the Wisconsin Business Corporation Law, as follows:

1. The present name of the Corporation (prior to any change effected by this amendment) is "Oshkosh Truck Corporation".
2. Article First of the Restated Articles of Incorporation of the Corporation is amended to read as follows:

"FIRST: The name of the Corporation is OSHKOSH CORPORATION."

3. The foregoing amendment was adopted by the Board of Directors of the Corporation on November 15, 2007 and by the Shareholders of the Corporation on February 5, 2008 in accordance with Section 180.1003 of the Wisconsin Business Corporation Law.
4. The foregoing amendment shall be effective as of the close of business on February 5, 2008.
