**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of July 1, 2010 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as successor by merger to Wachovia Bank, National Association, as administrative agent (the "Administrative Agent") with a place of business at 301 Tryon Street, 28th Floor, Charlotte, North Carolina 28288, in connection with the grant of security interests in certain trademarks by **BROOKS EQUIPMENT COMPANY, INC.**, a Delaware corporation and **CHIEF SUPPLY CORPORATION**, a Delaware corporation (the "Assignors"), in favor of the Administrative Agent.

WITNESSETH:

WHEREAS, the Assignors entered into an agreement with the Administrative Agent which was recorded in the Trademark Division of the United States Patent and Trademark Office on September 14, 2005 at Reel 3159, Frame 0665 for the purpose of providing certain trademarks as collateral security for the payment and performance of certain obligations of the Assignors to the Administrative Agent; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall mean all of the Assignors' right, title and interest of every kind and nature as of the date hereof in the Assignors' trademarks and trademark license agreements (including, without limitation, those items listed on Schedule A hereto, (each, a "Trademark")), together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its security interest in the Trademark Collateral, together with all products and proceeds thereof, including without limitation, any claims by Assignors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark, without representation, warranty or recourse of any kind or nature (together with the Trademark Collateral, the "Trademark Rights").

3. Reassignment. The Administrative Agent hereby reassigns, grants and conveys to Assignors, without any representation, recourse or undertaking by the Administrative Agent, all of the Administrative Agent's right, title and interest in and to the Trademark Collateral and the Trademark Rights.
