## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“Assignment”) is effective as of April 1, 2010 (the “Effective Date”) by and between THE DOW CHEMICAL COMPANY, a Delaware corporation having an office at 2030 Dow Center, Midland, Michigan 48674, USA (“Assignor”), and STYRON LLC, a Delaware limited liability company with its principal place of business at Michigan Division, 1604 Building, Midland, Michigan 48674, USA (“Assignee”) (each, a “party,” and collectively, the “parties”).

### BACKGROUND

WHEREAS, Assignor, STY Acquisition Corp. (“Purchaser”) and the Styron Holdcos have entered into a Sale and Purchase Agreement, dated as of March 2, 2010 (the “Purchase Agreement”; unless otherwise defined herein, capitalized terms shall be used herein as defined in the Purchase Agreement), pursuant to which Assignor has agreed to sell, and Purchaser has agreed to purchase, the Styron Equity Interests (as defined in the Purchase Agreement);

WHEREAS, Assignor desires to assign all of Assignor’s right, title and interest in the trademarks listed on the attached Schedule A (herein defined as “Trademarks”) to Assignee, and Assignee desires to receive the Trademarks from Assignor; and

WHEREAS, Assignee is the successor to that portion of the assets of the business of the Assignor to which the Trademarks pertain and such business is ongoing.

### TERMS

NOW, THEREFORE, in consideration of the above premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intent to be legally bound, the parties hereto hereby agree as follows:

1. Assignment. (a) Assignor hereby irrevocably assigns, transfers, conveys and delivers to Assignee all right, title and interest in and to all Trademarks, free and clear of any Encumbrances (other than Permitted Encumbrances), together with the goodwill symbolized by or associated exclusively with the Trademarks, including all associated trademark rights held by Assignor, for the United States and all foreign countries, including, without limitation, all registrations and applications for registration of the Trademarks, any renewals and extensions of the registrations and all corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter arising or in effect, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all claims, demands, and rights to recovery, damages or profit that Assignor may have for past, present or future infringement, misappropriation, unfair competition, dilution or other violations of such Trademarks, if any, and all rights to compromise, sue for, and collect on such claims, demands and rights to recovery in its own name and that of its successors and/or assigns, and all rights corresponding thereto throughout the world.

(b) Assignor hereby requests the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee and owner of the Trademarks and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.

2. Further Assurances. Assignor and Assignee shall each take, and shall cause their respective Affiliates to take, any and all additional actions as may be necessary or appropriate to effect the transactions contemplated hereby, including, but not limited to, execution of individual assignment documentation for filing with the authorities of each individual country. The responsibility to file assignments with the national trademark offices of each country shall be on the Assignee and the Assignee shall bear the cost of filing such assignments.

3. Conflict. If there is any conflict between the Purchase Agreement and this Assignment, each of the Purchase Agreement and this Assignment is to be interpreted and construed, if possible, so as to avoid or minimize such conflict, but, to the extent (and only to the extent) of such conflict, the Purchase Agreement shall prevail and control.

4. Counterparts. This Assignment may be executed and delivered (including by facsimile or other means of electronic transmission, such as by electronic mail in "pdf" form) in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement.

5. Governing Law. This Assignment shall be governed by, and construed in accordance with, the Laws of the State of New York.


