## ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks ("Assignment") effective as of the 15-th day of July, 2010 ("Effective Date"), is made by and between Spirits Product International Intellectual Property B.V., a corporation organized under the laws of The Netherlands, with effective place of management at 7, rue Nicolas Bové, L-1253 Luxembourg, Grand-Duchy of Luxembourg, duly represented by the Manager of Geneva branch Mr. Alexey Oliynik (hereinafter referred to as "Assignor") and Spirits International B.V., a corporation organized under the laws of The Netherlands, with effective place of management at 7, rue Nicolas Bové, L-1253 Luxembourg, Grand-Duchy of Luxembourg, duly represented by the Manager of Geneva branch Mr. Alexey Oliynik (hereinafter referred to as "Assignee").

WHEREAS, Assignor is the owner of the trademarks and of the trademark applications thereof set forth on the attached Schedule A, which is incorporated herein (collectively, the "Marks"); and

WHEREAS, Assignor and Assignee are parties to a certain Agreement of Sale And Assignment Of Rights To The Trademarks And All Rights Pertaining Thereto, executed contemporaneously herewith (the "Agreement"), pursuant to which Assignor agreed to assign, transfer, convey and deliver to Assignee all rights, title and interest in and to the Marks and to execute and allow the recordation of this instrument with the U.S. Patent and Trademark Office; and

NOW, THEREFORE, in consideration of the consideration set forth herein and in the Agreement, the foregoing premises and the mutual covenants contained herein and in the Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, intending to be legally bound, does hereby agree as follows:

1. Assignor hereby irrevocably sells, assigns, conveys, transfers, and delivers to Assignee (as successor to the business to which the Marks pertain), and Assignee hereby accepts such sale, assignment, conveyance, transfer, and delivery from Assignor of, all rights, title, and interest in and to the Marks, together with the goodwill of the business associated with and/or symbolized by the Marks and all rights to sue or to assert any claim, whether at law or in equity, against any third party for past, present or future infringement, misappropriation, dilution or misuse of the Marks, to obtain injunctive relief, and to recover or collect royalties, damages, and profits, for such past, present or future infringement, misappropriation, dilution or misuse of the Marks.

2. Assignor hereby authorizes Assignee to record this assignment with the U.S. Patent and Trademark Office.

3. THIS ASSIGNMENT SHALL BE CONSTRUED, PERFORMED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF SWITZERLAND, WITHOUT GIVING EFFECT TO ITS PRINCIPLES OR RULES OF CONFLICT OF LAWS.

4. This Assignment may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures hereto were upon the same instrument.
