**Memorandum of Assignment of Trademarks**

**THIS MEMORANDUM OF ASSIGNMENT OF TRADEMARKS**, is made this 15<sup>th</sup> day of February, 2010, by Adventure West Virginia Resort, LLC, a West Virginia limited liability company, having its principal place of business at Ames Heights Road, P.O. Box 78, Lansing, WV 25862 (hereinafter "Adventure WVR").

**WHEREAS**, Class VI River Runners, Inc., a West Virginia corporation, having its principal place of business at Ames Heights Road, P.O. Box 78, Lansing, WV 25862 (hereinafter "Class VI") heretofore used the trademarks VI (stylized), CLASS VI, AMERICA'S BEST WHITEWATER, and ON THE GORGE (hereinafter referred to as "the said marks"), all of which are registered in the United States Patent and Trademark Office as set forth on Schedule A attached hereto and made a part hereof for all purposes; and

**WHEREAS**, by that certain Asset Purchase and Contribution Agreement dated April 14, 2008, Class VI contributed substantially all of its assets in exchange for a certain number of Class B Units of Adventure WVR and Class VI did assign, transfer, set over, and convey unto Adventure WVR any and all rights that Class VI had in and to the said marks and the registrations therefor, together with the goodwill of the business in connection with which the said marks had been used and which is symbolized by the said marks, along with the right to recover for damages and profits for past infringements thereof;


**WHEREAS**, Adventure WVR makes and submits this Memorandum intending to and for the purpose of recording its ownership of the said marks as a matter of record with the United States Patent & Trademark Office.

**NOW, THEREFORE**, be it known that by virtue of the assignment, sale, transfer, contribution, and conveyance from Class VI to Adventure WVR made as part of and as documented in the Asset Purchase and Contribution Agreement dated April 14, 2008, Adventure WVR has been since said date and now is the lawful holder and owner of all rights, title and interest in and to the said marks and the registrations therefor for the United States and throughout the world together with the goodwill of the business in connection with which the said marks had been used and which is symbolized by the said marks, along with the right to recover for damages and profits for past infringements thereof.

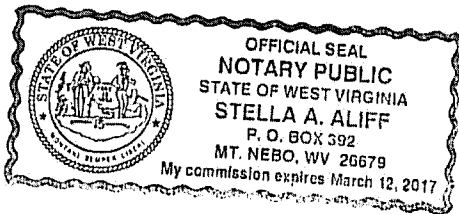
