TRADEMARK ASSIGNMENT**

THIS AGREEMENT is effective as of October 5, 2007.

WHEREAS, pursuant to an Asset Purchase Agreement by and among Deloitte Tax LLP ("Seller"), and eProperty Tax, Inc. (now named "Thomson Reuters (Property Tax Services) Inc.") 

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign unto Assignee, its successors and assigns all of its right, title and interest in and to the trademark listed on Schedule A, together with all the goodwill of the business symbolized by the trademark, and together with the right to sue and collect damages and/or profits for past infringements of the trademark, the intent hereof to be to substitute Assignee in the place of Assignor with regard to the trademark.
