ASSIGNMENT AND ASSUMPTION OF
TRADEMARK PURCHASE AND LICENSE AGREEMENT

This Assignment and Assumption of Trademark Purchase and License Agreement (“Assignment Agreement”) is entered into effective June 25, 2010, by and between Cumberland Farms, Inc. (“Cumberland”) and Gulf Oil Limited Partnership (“Gulf”).

WHEREAS, Chevron Intellectual Property LLC (“Chevron”) was the owner of certain intellectual property, including trademarks and domain names, relating to the “Gulf” brand (the “Marks”);

WHEREAS, by and through a Trademark Purchase and License Agreement dated as of January 11, 2010, as amended (the “Trademark Agreement”), a copy of which is attached hereto as Schedule 1, Chevron, together with Chevron U.S.A. Inc. (“CUSA”), conveyed all of their right, title, and interest in and to the Marks to Cumberland, subject to certain continuing obligations; and

WHEREAS, Cumberland desires to sell the Marks and assign the Trademark Agreement to Gulf and Gulf is desirous of acquiring the Marks and assuming all obligations under the Trademark Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Cumberland and Gulf hereby agree as follows:


1. Cumberland hereby assigns, sells, and transfers unto Gulf all of its rights, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and the Trademark Agreement, and Gulf hereby covenants to discharge the duties and obligations thereunder, including but not limited to the five annual payments set forth therein.

2. Upon execution of this Assignment Agreement, Gulf shall pay to Cumberland the sum of Thirty Five and 00/100 Million Dollars (USD \$35,000,000). Gulf shall also pay five annual One Million Dollar (USD \$1,000,000) payments directly to Chevron as set forth in Section 2 of the Trademark Agreement.

3. Gulf shall indemnify, defend and hold harmless Cumberland and its affiliates, directors, officers, employees, shareholders, members, managers, agents and representatives (the “Cumberland Parties”) from any and all liabilities, damages, losses, claims, causes of action, costs and expenses, of any kind or nature (including without limitation, reasonable attorneys’ fees and technical consultants’ fees and expenses), as they come due and amounts paid in judgment or settlement incurred or sustained by or asserted against the Cumberland Parties in any manner directly or indirectly arising out of or relating to any breach by Gulf, its employees, agents or subcontractors of any covenant or other agreement set forth in this Assignment Agreement or the Trademark Agreement, except for damages related to the sole negligence of Cumberland. The indemnification rights of the Cumberland entities will survive this Assignment Agreement and shall not in any way be altered, diminished or limited without agreement by Cumberland in writing prior to a claim being made.

4. In furtherance of this Assignment Agreement and the parties' understandings, rights and obligations herein, Cumberland and Gulf shall fully execute the trademark assignment document attached hereto and the parties further consent to the recordation of said fully-executed document with any governmental agency as may be required or reasonably deemed necessary to carry out the full force and effect of this Assignment Agreement.




