TRADEMARK ASSIGNMENT

3. Assignor does hereby authorize and request the Commissioner of Trademarks of the United States, record said assignment so as to show Assignee as owner of the Trademark.
4. This Assignment may be executed in any number of counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


