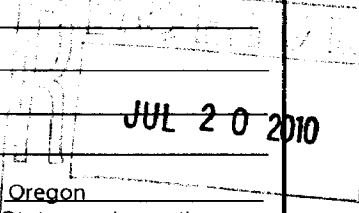

ADDENDUM TO SECURITY AGREEMENT

This Addendum to Security Agreement is an addendum to that Commercial Security Agreement ("Security Agreement"), dated February 19, 2010 executed by West Oregon Wood Products, Inc., an Oregon corporation, with its principal place of business at 2305 Second Street, Columbia City, OR 97018 ("Grantor"), in favor of St. Helens Community Federal Credit Union, with its principal place of business at 1720 St. Helens Street, St. Helens, OR 97051 ("Lender").

The purpose of this Addendum is to specify that the Collateral in which Lender has a security interest pursuant to the Security Agreement includes all of Grantor's right, title and interest in, to and under the following Intellectual Property:

1. All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth in **Exhibit A** hereto (collectively, the "Patents");
2. All trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth in **Exhibit B** hereto (collectively, the "Trademarks");
3. Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the rights identified above;
4. All licenses or other rights to use any of the Patents or Trademarks, and all license fees and royalties arising from such use to the extent permitted by such license or rights;
5. All amendments, extensions, renewals and extensions of any of the Patents or Trademarks; and
6. All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing, and all license royalties and proceeds of infringement suits, and all rights corresponding to the foregoing throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part of the foregoing.

This Addendum to Security Agreement may be presented for recordation as constructive notice that Grantor, the owner of the Intellectual Property identified in the exhibits attached hereto, has granted to Lender a security interest in the Intellectual Property, and the exclusive rights comprised in the Intellectual Property, to secure payment of a debt.

IN WITNESS WHEREOF, Grantor has executed this Addendum to Security Agreement as of June 18, 2010.


