RELEASE OF TRADEMARK INTEREST

This RELEASE OF TRADEMARK INTEREST is executed as of July 1, 2010 by BANK OF AMERICA, N.A., successor in interest by merger to Fleet National Bank (the "Bank") with reference to that certain Notice of Grant of Security Interest In Trademarks, dated as of April 1, 2005 (the "Security Agreement") between the Bank and FIND/SVP, INC., TTECH ACQUISITION CORP., and GUIDELINE RESEARCH CORP. (c) to the extent the Bank shall be deemed to have any right, title or interest in the Trademarks, transfers to the Company all of such right, title and interest, without any representation, warranty, undertaking, or recourse.


